Impact of IWV Groundwater Authority Replenishment Fee

The HVMCA uses two sources of water for our grounds irrigation. Most of our small common areas (Heritage North, Norma Street, Ward Ave, etc) along with the smaller park on Roosevelt use IWV Water District water, the same as you use for your household. Additionally, HVMCA has its own production well located adjacent to the pool to provide water for our large park. For the past five to six years, the HVMCA Board of Directors has worked, through our Manager, to design and implement lower water usage landscaping. Ramon, Jaime and Ernesto have implemented these plans in numerous common areas of the Association.

Recently, the IWV Groundwater Authority passed one fee increase and adopted one new fee. A pumping fee increase was adopted July 16th by the IWVGA increasing the rate from \$30 per acre-foot to \$105.00 per acre-foot. (An acre-foot is approximately 326,000 gallons). The second fee adopted on the 20th of August is a Replenishment fee that imposes a fee of \$2,130 per acre-foot. The IWVWD water usage and our production well are subject to both fees. At this time the impact of these IWV Groundwater Authority fees is being assessed by the Association. Preliminary estimates based on historical usage data indicate that we could be facing an annual cost of over \$46,000 for these fees. Spread across 12 months and 289 HVMCA owners this amounts to a cost of \$13.32 per month per owner. This is on top of the IWVWD collected fee increase that you will see on your personal water bill every month (an increase of approximately \$6 per 1,000 gallons used).

At this time we do not know when the IWVGA will start collecting these fees. Our best guess at this time is that they will be imposed no sooner than January 2021; we suggest you read the local media or monitor the IWVGA website to keep apprised of any decisions made.

In response to these fees, the HVMCA is working with our professional grounds crew to devise strategies to reduce our water use. As these plans begin to take shape, we will inform the community and solicit feedback. We all need to use water wisely and these fees will encourage the HVMCA to take a closer look at our water usage.

CLUBHOUSE NEWS

HOLIDAY DECORATION POLICY.

As the holidays approach, please remember the guidelines on decorations.

The Architectural Committee, offers a blanket approval for the installation of Holiday Decorations within the Heritage Village Community provided the following conditions are met:

- 1. Christmas, Hanukkah and Kwanza decorations may be installed beginning the day after Thanksgiving and must be removed no later than the following January 31.
- 2. Decorations for other holidays, such as Halloween or Easter, may be installed two weeks prior to the holiday. They must be removed no later than one week following the holiday.
- 3. Homeowners not removing decorations within the designated period will receive a notice of violation and may be fined.
- 4. Any homeowner in disagreement with this policy and who has received a fine may request, in writing, a Board hearing
